Information on Law School Applicants, Applications, Admissions, and Matriculations by Virginia Tech Students and Alumni/ae

This handout provides information on how many Virginia Tech students and alumni/ae have applied to law schools over the past ten years, how many have been accepted by one or more law schools, where Virginia Tech degree holders have enrolled in law school, and related data. This summary and the accompanying tables are based on annual reports provided by the Law School Admission Council (LSAC) to the University Pre-Law Advisors at Virginia Tech. The most recent reports cover applications during the 2011-2012 academic year, for admission to law schools beginning in the fall of 2012. Information on applicants, applications, and acceptances during the 2012-2013 academic year is expected to be available in 2014.

Please keep in mind when reviewing this information that standards for admission to law schools vary, both across schools and from year to year. In addition, admission rates are based on where individuals choose to apply, not only on applicants' credentials. If one seeks admission to one or more law schools, it is important to apply to an appropriate range.

During the academic year 2011-2012, approximately 75.6% of Virginia Tech (VT) students and alumni/ae who had taken the Law School Admission Test (LSAT) but who had not previously enrolled in law school applied to one or more law schools. During that academic year, 86 Virginia Tech seniors and 103 Virginia Tech alumni/ae *applied* to a total of 169 law schools. Of these 189 Virginia Tech degree holders, 163 (86.2%) were *admitted* to 147 different law schools within 38 states and the District of Columbia. (78 of the seniors, or 90.7%, were admitted to one or more law schools.) Of the 163 Virginia Tech degree holders admitted to one or more law schools during the 2011-2012 academic year, 126 (61 seniors) *matriculated* in the fall of 2012 at 58 different law schools within 27 states and the District of Columbia. The average grade point average (GPA) of those who applied to law school from Virginia Tech during the 2011-2012 academic year was 3.31; and the average highest score on the Law School Admission Test (LSAT) for those applying to law schools that year was 155.9.

Table 1 summarizes some of these data, along with comparable data from prior years. In addition, table 2 shows the first majors of those from Virginia Tech who disclosed this information.

The Pre-Law Advisors have complete lists of the law schools to which Virginia Tech students and alumni/ae applied, where they were admitted, and where they matriculated during the past ten years. Briefly, during the academic year 2011-2012, Virginia Tech degree holders were admitted to all eight of the accredited law schools in Virginia, and in the fall of 2012 enrolled in seven of them: Appalachian School of Law, George Mason University School of Law, Regent University School of Law, University of Richmond School of Law, University of Virginia School of Law, and Washington and Lee University School of Law. Virginia Tech degree holders were admitted to six law schools in Washington, D.C., and enrolled in three of them: American University Washington College of Law, Catholic University of America – Columbus School of

Law, and George Washington University Law School. In the fall of 2012, Virginia Tech degree holders also enrolled in law school at: The University of Alabama School of Law, Atlanta's John Marshall Law School, University of Baltimore School of Law, Baylor University School of Law, Brooklyn Law School, University of California Hastings College of the Law, California Western School of Law, Campbell University's Norman Adrian Wiggins School of Law, Capital University Law School, Charleston School of Law, Charlotte School of Law, University of Dayton School of Law, Earle Mack School of Law at Drexel University, Elon University School of Law, Faulkner University's Thomas Goode Jones School of Law, University of Florida's Fredric G. Levin College of Law, Florida State University College of Law, Golden Gate University School of Law, University of Kansas School of Law, University of Kentucky College of Law, Marquette University Law School, University of Maryland Francis King Carey School of Law, University of Miami School of Law, University of Mississippi School of Law, University of New Hampshire School of Law, New York Law School, New York University School of Law, North Carolina Central University School of Law, University of Oregon School of Law, Pace University School of Law, Pennsylvania State University Dickinson School of Law, Pepperdine University School of Law, University of Pittsburgh School of Law, Saint Louis University School of Law, University of South Carolina School of Law, Southwestern Law School, Suffolk University Law School, Syracuse University College of Law, University of Tennessee College of Law, Texas Tech University School of Law, Tulane University Law School, Vanderbilt University Law School, Vermont Law School, Villanova University School of Law, Wake Forest University School of Law, West Virginia University College of Law, Widener University School of Law, and Yale Law School.

During the academic year 2011-2012, individuals from Virginia Tech were accepted by seventy-eight additional law schools but chose not to enroll at them in the fall of 2012. Those schools include: The University of Arizona James E. Rogers College of Law, Boston University School of Law, University of California Berkeley School of Law, University of California Davis School of Law (King Hall), Columbia University School of Law, Georgetown University Law Center, Harvard Law School, University of Michigan Law School, University of North Carolina School of Law, Northwestern University School of Law, Rutgers University School of Law – Camden, Stanford University Law School, and University of Texas School of Law, among others.
